- The club wishes to stage **any** motorsport events throughout the year (this includes, but is not limited to, Touring Assemblies and Driver Training)
- The club wishes to retain its voting rights (if it currently holds them). Please note that clubs seeking to obtain voting rights will also need to be affiliated as a Sporting Club, however, there are additional requirements to be eligible to hold voting rights
- Clubs who have members that hold Motorsport Australia competitor licences (e.g. Speed, Clubman Rally, National Circuit, etc.) need to be a financial member of a Motorsport Australia-Affiliated Sporting Car Club for their licence to be valid

## Clubs Seeking to Affiliate with Motorsport Australia for the First Time

**Clubs Seeking to Affiliate with Motorsport Australia for the first time are advised to submit the following as part of their application.**

- Club's current constitution and by-laws (containing the club's objects)
- Completed affiliation application form, ensuring each section is completed
- Verification of club's legal status (e.g. Certificate of Incorporation)
- Payment of requisite affiliation fees

## Application Statement

**I, FOR AND ON BEHALF OF, THE CLUB NAMED IN 'CLUB DETAILS' SECTION OF THE APPLICATION FOR AFFILIATION:**

1. Make application for affiliation with Motorsport Australia
2. Understand that if Motorsport Australia accepts your application it will grant to the club all the benefits, advantages, privileges and services associated with the 'Enthusiast' type of affiliation membership of Motorsport Australia
3. Acknowledge that as a condition of acceptance of this application that this club undertakes to be bound by the Constitution of Motorsport Australia and the National Competition Rules (NCR) together with all other regulations and instructions issued on behalf of Motorsport Australia
4. Understand that any breach of such requirements may render the club liable to loss of affiliation as well as other penalties as provided for by the Constitution, NCR or any other remedy available to Motorsport Australia
5. Will provide a register of the club's financial members within five (5) working days upon written request of Motorsport Australia
6. Undertake the prescribed methods (as stated by Motorsport Australia) in which to obtain relevant access to Motorsport Australia's insurance program for the club's social, noncompetitive events during the affiliation period, this may require the obtaining of a permit from Motorsport Australia
7. Understand that any breach may render invalid insurance indemnity for any event in question
8. Duly authorise one of the persons specified as the club's State Council Delegate or Alternate Delegate to be the nominated representative of the club at Motorsport Australia State Council meetings in its allocated Motorsport Australia jurisdiction
9. Accept that this application for affiliation is subject to the approval of Motorsport Australia. Should the club's application for affiliation with Motorsport Australia be rejected, Motorsport Australia is not obliged to give reasons for rejecting the club's application for affiliation
