Why the role exists

The CFO role exists to provide leadership, direction and management of Motorsport Australia's finances whilst contributing to the overall strategic development of the business. The CFO will ensure the provision of sound financial management, planning and related financial advisory and reporting services that minimise Motorsport Australia (and its related entities) risk and liabilities and enhances the overall financial interests of Motorsport Australia. This role is also responsible to implement & oversee Motorsport Australia's risk management framework.

Duties and Responsibilities

Budgeting and Reporting

- Manage the preparation, implementation, reporting and monitoring of budgets forecasts and other projections across Motorsport Australia and its related entities
- Manage preparation of monthly management accounts
- Prepare and present monthly financial and management reports and commentary
- Review / audit monthly Profit and Loss, Balance Sheet and Cash Flow Statements and reconciliations for Motorsport Australia and its entities
- Prepare annual accounts / financial reports by discipline, commission or other as required
- Ensure continuous improvement in the areas of management, reporting, budgeting and forecasting
- Provide timely and accurate budget, financial and risk information, analysis and recommendations to the Board and Finance & Audit Committee

Statutory Obligations

- Manage, prepare and submit financial statements and annual statutory accounts in accordance with relevant accounting standards, policies, procedures and audit requirements
- · Manage annual audits of Motorsport Australia and its related entities
- · Manage preparation and sign-off of the Motorsport Australia Annual Report

Risk Management

- Ensure the operation of effective risk management strategies and controls across all areas of Motorsport Australia activities
- · Construct and monitor reliable control systems
- Effective risk reporting to the Motorsport Australia Board, Finance, Risk & Audit Committee (FRAC) and the Senior Leadership Team.

Financial Management

- Provide high level financial advice within Motorsport Australia and its related entities
- Ensure relevant policies and procedures are in place for all matters pertaining to financial management
- Ensure appropriate banking and investment facilities are in place to support Motorsport Australia's financial requirements

- Provide financial expertise and advice on the management of investments
- Act as Executive Officer to the Motorsport Australia Finance, Risk & Audit Committee
- Manage and review the accounting and financial operations, structures and processes of the
 organisation in order to ensure best practice and adherence to accounting standards, policies and
 procedures
- Ensure invoicing in accordance with Motorsport Australia policy and contractual requirements
- Review fringe benefit arrangements for Motorsport Australia

Staff Management

- Plan, direct and oversee the effective operations and work of the department
- Coach, mentor, and develop staff, including providing regular feedback, recognition, setting goals, undertaking performance and development reviews and providing career development and opportunities
