##### ***Matters from Race 2:***

As the race was suspended and did not resume, the Stewards did not declare any classifications for Race 2 as regulated by D12.3.5

###### *Race Director Incident Determinations*

There were no determinations.

###### *Stewards' Decisions – Penalties imposed*

Following a report and investigation by the RD, that Matthew McLean Car 54, failed to comply with the Qualifying Procedure Instructions, the Stewards imposed a Time Penalty of two (2) minutes on Car 54 to be held at its Pit Bay at the commencement of the Super2 Qualifying Session.

For causing a Red Flag during the Session, Reef McCarthy Car 61 lost its fastest lap and took no further part in the session. .

##### ***Matters from Event Media Promotional Schedule:***

Following a report and investigation by the RD, that Jayden Ojeda the Driver of Car 31 was late to a scheduled promotional event for round 4 of the 2021 Dunlop Super2 Series, the Stewards imposed a Fine of \$1000, wholly suspended until 31/12/2021 subject to any further breach of Rule E8.1.3

#### Stewards' Decisions – Penalties imposed

Following a report and investigation by the RD, the following Drivers entered the Pit Lane after the Chequered Flag was displayed in breach of Rule D11.5.10.3. The Stewards imposed a Fine of \$500 on the following Drivers;

The Stewards imposed Fines for exceeding the 40kph speed limit in Pit Lane:

#### Stewards' Decisions – Penalties imposed

Following a report and investigation by the RD, that Matt McLean Car 54, crossed the Control Line more than once at the end of the Session in breach of Rule D3.1.3, the Stewards imposed a Fine of \$500.

Following a report and investigation by the RD, that Tim Blanchard Car 88, entered the Pit Lane after the Chequered Flag was displayed in breach of Rule D11.5.10.3, the Stewards imposed a Fine of \$500.

The Stewards imposed Fines for exceeding the 40kph speed limit in Pit Lane:

- in the sum of \$200 on Elly Marrow Car 8 - 48kph
- in the sum of \$200 on Elly Marrow Car 8 - 46kph (second breach)

### **Matters from Competitors Authorised Representatives & Drivers Briefing:**

The Stewards imposed a Fine of \$250 on Matt McLean Car 54, for a late arrival and after the Briefing had commenced.
