**STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update Final: issued Sunday 31st July 2022 at 1800hrs.**

#### **Matters from Race 23:**

##### Deputy Race Director Incident Determinations

The DRD determined that the following Incidents did not warrant referral to the Stewards within the Race, as neither Driver was wholly or predominately to blame for the Incident. :

- The Incident on Lap 3, involving Car 3 Tim Slade, and Car 49 Jordan Boyce.
- The Incident on Lap 13, at Turn 6 involving Car 26 David Reynolds, and Car 31 James Golding.

##### Stewards' Decisions – Penalties imposed

The following Penalties were imposed during the Race:

- A 15 second Time Penalty on Car 25 Chaz Mostert for contact to Car 17 Will Davison on Lap 6 at Turn 6, causing Car 17 to lose multiple positions.

#### **Matters from Race 22:**

##### Deputy Race Director Incident Determinations

The DRD determined that the following Incident did not warrant referral to the Stewards within the Race, as neither Driver was wholly or predominately to blame for the Incident. :

- The Incident on Lap 1, Turn 15 involving Car 34 Jack le Brocq and Car 49 Jordan Boyce.

##### Stewards' Decisions – Penalties imposed

- A 15 second Time Penalty on Car 10 Lee Holdsworth for an unsafe release from its Pit Bay causing contact to Car 20 Scott Pye.
- A Pit Lane Drive through Penalty (PLP) on Car 99 Brodie Kosteki for an unsafe release whilst not all Team Members were free of the Car.

- A PLP on Car 56, Jake KostECKI, for exceeding the Pit Lane Speed Limit, (48kph) at Pit Entry.
