### STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update 3: issued Sunday 10 July 2022 at 1745hrs.

#### **Matters from Race 20:**

##### Deputy Race Director Incident Determinations

The DRD determined that the following Incident did not warrant referral to the Stewards within the Race:

- The Incident on Lap 1, Turn 3 involving Car 20, Scott Pye, and Car 17, Will Davison, as neither Driver was wholly or predominately to blame for the Incident.

##### Stewards' Decisions – Penalties imposed

The following Penalties were imposed during the Race:

- A PLP on Car 10, Lee Holdsworth, for a breach of Schedule B3, Article 4.4.1.3 (When shown the Blue Flag, the Driver concerned must allow the following Car to pass at the earliest opportunity) for failing to allow Car 6, Cam Waters to pass after being shown the in-car Blue Flag.
- A 5 Second Time Penalty on Car 11, Anton de Pasquale, for a breach of Schedule B2, Article 2.1.1 (Careless Driving) contact with Car 97, Shane van Gisbergen, at Turn 13 on Lap 88.

#### **Matters from Qualifying for Race 20:**

##### Stewards' Decisions – Penalties imposed

Following a Request from Tickford Racing, a DRD investigation and an admission by Car 17, Will Davison, of a breach of Schedule B2, Article 2.1.1 Careless Driving - impeding of Car 5 at Turn 5 during Qualifying, the Stewards imposed the Penalty of the loss of 1 Grid Spot in Race 20 on Car 17.

**Other Matters:**

Stewards' Decisions – Penalties imposed

Following a DRD Investigation and an admission by Brad Jones Racing of a breach of Rule E8.1.3 & Supplementary Regulation 7.1.1 by Car 4, Jack Smith, (failed to comply with Promotional Schedule (non-attendance at the National Anthem prior to start of Race 19) the Stewards imposed the penalty of a fine of \$2,000 on Brad Jones Racing (of which \$1000 is suspended until 31/12/2022 subject to there being no further breach of a similar nature in the period).

**Matters from Race 19:**

Deputy Race Director Incident Determinations

The DRD made the following Determinations within the Race:

- That the Incident involving contact between Car 4, Jack Smith, Car 96, Macauley Jones, and Car 22, Chris Pither, at Turn 11 on Lap 1 did not warrant referral to the Stewards as no Driver was wholly or predominately to blame.

Stewards' Decisions – Penalties imposed

The following Penalties were imposed during the Race:

- A 15 second Time Penalty on Car 5, James Courtney, for a Driving Infringement (Careless Driving – contact with Car 31, James Golding, at the start of the Race).

**Matters from Qualifying for Race 19:**

After receiving a Request for Investigation from Matt Stone Racing alleging that Car 34 was impeded by Car 56 in the Session, the DRD reviewed the available video footage and determined that the Incident did not warrant referral to the Stewards as there was no breach of the Rules evident.
