STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update 2 FINAL: issued Sunday 1 May 2022 at 1735hrs.

Matters from Race 12:

Deputy Race Director Incident Determinations

There were no Determinations.

Stewards' Decisions – Penalties imposed

During the Race the Stewards imposed:

- a 15 Second Time Penalty on Car 18, Mark Winterbottom, for Careless Driving after Car 18 made contact with the rear of Car 55, Thomas Randle, at Turn 5 on Lap 1 causing Car 55 to spin and lose multiple positions;
- a Pit Lane Drive Through Penalty on Car 99, Brodie Kosteki, after Car 99 made contact with Car 56, Jake Kosteki, at Turn 7 on Lap 45 as a result of which Car 56 left the Race Track and became beached in the sand trap at the exit of Turn 7 and was unable to continue in the Race. Because the Penalty was not served during the Race, a Post-Race Time Penalty of 23 seconds was added to Car 99's Race time.

Matters from Race 11:

Deputy Race Director Incident Determinations

During the Race the DRD, in consultation with the DSA, investigated the following Incidents and determined in each case that, in the case of the first two, that no Driver was wholly or predominantly to blame, and in the case of the last, that no breach of the Rules was observed:

- an Incident on Lap 1 when Car 56, Jake Kosteki, and Car 10, Lee Holdsworth, had contact at Turn 2 as a result of which Car 10 sustained damage;
- an Incident on Lap 1 when as a result of contact between Car 34, Jack le Brocq, and Car 20, Scott Pye, Car 20 left the Race Track and collided with the wall on the start-finish straight;
- an Incident at Turn 6 on Lap 39 when contact occurred between Car 97, Shane van Gisbergen, and Car 26, David Reynolds.

Stewards' Decisions – Penalties imposed

During the Race the Stewards imposed a 5 Second Time Penalty on Car 6, Cam Waters, for gaining a lasting advantage upon re-entering the Race Track at Turn 7 on Lap 27.
