Matters from Race 2:

<u>Deputy Race Director Incident Determinations</u>

There were no determinations.

Stewards' Decisions - Penalties imposed

Following a post-race DRD investigation and admission by Cooper Murray Car 88 to a breach of Schedule B2 Article 2.1.1 Careless Driving (contact on Car 78 at Turn 10 on Lap 2 causing Car 78 to make contact with the wall and take no further part in the race) the Stewards imposed a post-race PLP (25 seconds) added to Car 88's race time for Race 2.

Matters from Race 1:

Deputy Race Director Incident Determinations

The DRD, in consultation with the DSA, reviewed available vision and determined not to refer the following matters to the Stewards as there was no evidence to establish a breach of Rules:

- Contact between Car 22 and Car 39 at Turn 11 on Lap 1.
- Contact between Car 18 and Car 92 at Turn 4 on Lap 9.

Stewards' Decisions - Penalties imposed

Matt Chahda Car 18 for a breach of Schedule B2 Article 2.1.1 Careless Driving (contact on Car 25 at Turn 11 on Lap 8) the Stewards imposed a 5 second time penalty on Car 18 in Race 1.

Matters from Qualifying for Race 1:

Deputy Race Director Incident Determinations



Having received a Request for Investigation from Tickford Racing alleging Car 11 impeded Car 6 at Turn 3 the DRD, in consultation with the DSA, reviewed the incident using available vision and determined not to refer the matter to the Stewards as no breach of Rules could be established.

Stewards' Decisions - Penalties imposed

Brad Vaughan Car 5 for a breach of Schedule B2 Article 2.1.2 Reckless Driving (causing collision with Car 70) the Stewards imposed the penalty of disqualification of Car 5 from Qualifying, Car 5 to start Race 1 from the Pit Lane and a fine of \$3000 with \$1500 suspended to 31/12/23.

Brad Vaughan Car 5 for a breach of D6.1.12 (causing a red flag during Qualifying) the Stewards imposed the prescribed penalty of deletion of Car 5's fastest lap time at the time of the red flag (1:15.4629 set at 0948:37hrs).

Following a post-session DRD investigation and admission by Ryan Wood Car 2 to a breach of Rule D11.4.2 (exceed Pit Lane Speed Limit (46kph)) the Stewards imposed the penalty of a fine of \$350.

Following a post-session DRD investigation and admission by Callum Walker Car 33 to a breach of Rule D11.4.2 (exceed Pit Lane Speed Limit (46kph)) the Stewards imposed the penalty of a fine of \$350.

Following a post-session DRD investigation and admission by Mason Kelly Car 22 to a breach of Rule D11.4.2 (exceed Pit Lane Speed Limit (62kph)) the Stewards imposed the penalty of a fine of \$750.

Following a post-session DRD investigation and admission by Matt Chahda Motorsport Car 18 to a breach of Rule D21.3.5 (Judicial in-car camera did not record session) the Stewards imposed the penalty of a fine of \$2000 with \$1000 suspended to 31/12/23.
