Sunday 25 February 2024

Matters from Race 2:

Deputy Race Director Incident Determinations

The DRD reviewed the following Incidents and determined they did not warrant referral to the Stewards:

- The Incident at the start of the Race involving Car 4, Cameron Hill, and multiple Cars. The available broadcast footage (including from overhead helicopter) demonstrated that no one Driver was wholly or predominately to blame for the Incident.
- The Incident involving Car 100, Mark Winterbottom, and Car 2, Ryan Wood, at Turn 21 on Lap 6. The available broadcast footage demonstrated that Car 100 was not to blame for the Incident.
- At the Request of Matt Stone Racing Pty Ltd for a post-race investigation, the allegation that Car 9, Jack Le Brocq, shortcut the Circuit at Turn 12 and gained a lasting advantage over Car 10, Nick Percat. The available broadcast footage did not establish a breach of the Rules.

Stewards' Decisions - Penalties

During the Race, the Stewards imposed a 5 second Time Penalty on Car 88, Broc Feeney, for a Driving Infringement (Careless Driving: Schedule B2, Article 2.1.1 - the available broadcast footage (including from overhead helicopter) demonstrated that Car 88 caused the collision with Car 31, James Golding, and that Car 31 lost position as a result.

After the Race, the Stewards imposed the following penalties:

- A 59 second Time Penalty on Car 4, Cameron Hill, for failing to comply with the CPS requirements (prescribed time penalty – see Rule D11.1.3.5).
- Following a post-race investigation and an admission of a breach of Rule E3.3.7 (fail to ensure equipment or items that it moves within the Circuit is moved safely and with due regard to the safety of all persons within the immediate area) by Tickford Racing Pty Ltd, the Stewards imposed a fine of \$3,000 on Tickford Racing Pty Ltd, \$1,500 of which is suspended until 31/12/2024 pending no further breach of the rule in the interim period.
