



# NSW Rally Vehicle Registration Scheme

## Certifier Application



Motorsport Australia may appoint Certifiers for the Rally Vehicle Scheme subject to the fulfilment of the following criteria:

- Be a licenced Motorsport Australia Scrutineer – minimum Bronze level
- Be a qualified motor mechanic
- Be the owner/operator of a mechanical repair business with the business and premises licenced by the MVRIC

A Motorsport Australia RVS Certifier will be obligated to maintain an accurate database of all inspections, including the details of those inspections. A Business Continuity Plan needs to be considered to ensure that the database is protected and recoverable in the event of fire, theft, etc.
