Scope

- a. Public Liability Insurance (PLI) will only apply to a club affiliated with Motorsport Australia.
- b. Invited clubs must be affiliated with Motorsport Australia in order to be covered by Motorsport Australia insurances.
- c. Participants must be members of a club affiliated with Motorsport Australia and are not required to hold a Motorsport Australia Competition Licence.
- d. Participating motor cars if driven on public roads, must be road registered in a State or Territory of Australia (this term also refers to classic/historic and Rally plates or equivalent for use on public roads in a State or Territory of Australia) and must be roadworthy in accordance with the requirements of the State in which the event is being conducted. The use of a "Trade" plate (as used for the commercial transport of a vehicle) is not allowed.
- e. PLI coverage will be available for events conducted on public roads provided that the event does not involve any dynamic competition whatsoever.
- . PLI coverage will be available for Static Displays including "Concours d'Elegance", "Show 'n Shine" and the like.
- g. The number of passengers in each motor car must not exceed the registered carrying capacity of each motor car.
- h. Motorsport Australia Insurance applies only when other insurances do not apply.

Requirements

Event Organiser Details

- a. As these activities will not be competitions within the meaning of the NCR, no Motorsport Australia Stewards will be required. However, an Event Organiser must be appointed. The Event Organiser will have the responsibility of resolving any issues associated with the administration of the event and will have the responsibility of ensuring that standards in accordance with road laws and any other external agency are maintained and to be responsible as the point of contact if an issue requiring the involvement of the Motorsport Australia Administration arises.
- b. A list of participants must be maintained by the organising club.
- c. Applications will only be accepted 48 hours prior to the commencement of the event at the latest.
