

As a condition of the [Queensland Rally Vehicle Registration Scheme](#) (QVRVS), Motorsport Australia must advise the Queensland Department of Transport and Main Roads (QLD TMR) when a vehicle has its QVRVS Authority to Operate cancelled. Cancellation of a QVRVS Authority to Operate may occur in the following circumstances:

- As part of the process of the sale of the vehicle. A QVRVS Authority to Operate cannot be transferred to a new owner. The original owner must cancel the Authority to Operate (using this form) and the new owner must apply for a new QVRVS Authority to Operate
- Should an Authority to Operate not be renewed within the timeframe required by QLD TMR, the QVRVS Authority to Operate must be cancelled. A new QVRVS Authority to Operate may be applied for in accordance with the Guideline for QVRVS
- Should the vehicle not be able to meet the requirements of the Guideline for the QVRVS, or be unable to continue to meet those requirements as per the original application Inspection

NOTICE

If a Rally Vehicle is sold or otherwise disposed of, the existing vehicle registration and Authority to Operate (if applicable) must be cancelled by the disposer of the Rally Vehicle and the acquirer must make a new application for vehicle registration and an Authority to Operate in the name of the acquirer. When selling or otherwise disposing of a Rally Vehicle, the disposer does not need to obtain a safety certificate (QLD TMR) for the Rally Vehicle.
