MATTERS ARISING / NEW BUSINESS

MIN 0749 2025/-27 Motorsport Australia Off Road Championship – Organiser Requirements – V1 Draft CS Review

The Commission agreed to leave the item on the agenda until further discussions are had internally within Motorsport Australia. Leading into 2025 the Administration will be conducting a review of all appointed officials positions before they will be listed in the Organiser Requirements. The Commission agreed to a target date of late November for completion of the Organiser Requirements document.

MIN 0750 2025 Off Road Appendix

The Commission Discussed the value of continuing to publish Off Road Kart and Stadium Standing Regulations despite the lack of permitted events for an extended period of time. The Commission noted that keeping regulations current is far easier than trying to bring old regulations back into circulation.

The Commission agreed that Off Road Kart Standing Regulations relate to junior involvement in the sport and agreed to discuss recommendations at the next meeting.

MIN 0752 Off Road Checkers Module Review

The Commission was provided with background information on the interest internally within Motorsport Australia to move to a digital Off Road Checkers Manual to improve accessibility with the aim of increasing the number of officials with the accreditation. The Commission agreed to discuss the matter with the Officials Manager to put a plan in place for 2025 and beyond.

MIN 0753 Off Road Specific Requirements Art. 7.2(a)(vii) Rule Clarification

The Commission clarified the ruling in Art. 7.2(a)(vii) in relation to the permitted mounting location of the spare wheel in a performance 2WD Ute. They noted that under the existing regulations, the competitor's proposed location is permitted.

Upon further discussion, the Commission agreed to change the wording in 7.2(a)(vii) to include "and their mountings" in an effort to make the regulation clearer.

MIN 0754 SXS Cage Review Process

The Commission was provided with background information on the issues regarding SXS Cage approvals and agreed that there is a requirement for a set of specific regulations to be written with a suggested implementation date of 2026.

The Commission agreed to work with the Motorsport Australia Technical Department to prepare the regulations in time for 2026.

MIN 0755 Main Hoop Permitted Designs

The Commission agreed to approve the proposed amendment to the Off Road Appendix General Requirements Article 9.3(g) noting that the amendment is a formalisation of the process that is already in place in relation to permitting main hoop designs.

MIN 0756 AORC Sporting Regulations 2025-27

The Commission agreed to represent the regulations at the next meeting after receiving feedback and suggestions on any further inclusions .

MIN 0757 Off Road Technical Working Group

The Commission confirmed that the Off Road Technical Working Group Terms of Reference had been ratified in the previous meeting and are now ready to suggest and select members.
