Code (Code) or the National Competition Rules (NCR), including their Appendices.

Any HEADING is for reference only and has no regulatory effect.

1. AUTHORITY

A Circuit Lap Record Attempt will be held under the FIA International Sporting Code including Appendices, the National Competition Rules of *Motorsport Australia*, these Standing Regulations and the *Supplementary Regulations* for the *Event*.

2. INTRODUCTION

A Circuit Lap Record Attempt is conducted on a *Circuit* holding a Motorsport Australia Track Licence. A Circuit Lap Record Attempt is a type of Automobile Demonstration and cannot be part of any other type of activity.

Any vehicle demonstration at a permanent Circuit that is referred as setting or attempting to set a lap record, in any form, must comply with these regulations.

3. OFFICIALS

Each Essential Official will be appointed as per the NCR.

When a Circuit Lap Record Attempt activity occurs at a race meeting, all officials required for the race meeting must remain in position whilst this activity is in progress.

When a Circuit Lap Record Attempt activity is performed outside of a race meeting, then the circuit must have at least one Marshal per Marshal point whilst the activity is in progress.

4. AUTOMOBILES

Each *Automobile* must comply with Technical Appendix - Schedules A and B of the *Manual* and be an *Automobile* that would be permitted to compete on that Circuit.

Tyres are subject to Scrutineer's approval.

After scrutineering, an *Automobile* which has been modified in any way which may affect its safety must be represented for further examination prior to starting a run.

Any Electric Vehicle (EV) used under these regulations must be compliant with the Electric Vehicle Standing Regulations.

Any Automobile that would not normally be permitted to compete on a Circuit may apply to Motorsport Australia for approval to perform a Circuit Lap Record Attempt.

5. LICENCES

Each *Driver* must hold a Motorsport Australia National Competition Licence or an international licence to perform this activity. Refer to the General Appendix – Competition Licences of the *Manual*.

6. DRIVER APPAREL

Driver apparel including helmet must comply with Technical Appendix - Schedule D of the *Manual for a* National *Circuit Race*;

7. PADDOCK SPEED LIMIT

A limit of 10 km/h will apply in the paddock area.

8. TIMING

Timing will be recorded to at least 0.01 second.

9. PROCEDURE

The Supplementary Regulations and/or Driver briefing must include at least the following:

direction of travel;

flag signals;

number of Automobiles on the Course simultaneously;

number of laps per "run";

procedure for returning to the paddock.

10. RECOGNITION OF RECORD

Currently, lap records are not officially recorded or recognised by Motorsport Australia. Any lap record set via a Lap Record Attempt compliant with these regulations is unofficial only.
