



Appendix C – 2025 MOTORSPORT AUSTRALIA WA HQ Holden Racing State Championship

C.1 OBJECTIVE

- (i) The objective of the championship is to promote and foster the competition of racing cars complying with the MOTORSPORT AUSTRALIA *Manual, Circuit Race Appendix 3rd Category Touring Cars, Group 3H HQ Holden Technical Regulations*. The 2025 MOTORSPORT AUSTRALIA WA HQ Holden Racing State Championship (hereinafter called "the Championship") is open to all *Competitors* whose *Automobiles* comply with the aforementioned technical regulations.
- (ii) This Appendix is prepared in accordance with the 2025 MOTORSPORT AUSTRALIA Championship and Series Policy.

C.2 CATEGORY ORGANISERS

- (i) The Category Organisers of the Championship shall be the 'HQ Racing Association of Western Australia', herein referred to as "the Organiser".

C.3 CHAMPIONSHIP ELIGIBILITY

- (i) Each Automobile must conform to the MOTORSPORT AUSTRALIA Manual Technical Appendix, must comply with the provisions of the Circuit Race Appendix 3rd Category – TOURING CARS – Group 3H HQ Holden Technical Regulations as detailed in the MOTORSPORT AUSTRALIA Manual.
- (ii) The onus of proof of *Automobile* eligibility rests with the individual *Competitor* at all times.
- (iii) At the conclusion of each session at any State Championship Event/Round, Drivers can expect to be directed to parc fermé without returning to the pits or paddock and Automobiles having not been interfered with. Such Automobiles shall remain under control of the Chief Scrutineer as listed in the relevant Event's Supplementary Regulations.
- (iv) Any competing Automobile may be impounded at the discretion of the Chief Scrutineer.
- (v) Each *Automobile* shall display all required Championship and Category decals whilst competing. The position of these decals on the *Automobile* is detailed in the HQRA technical regulations. The position of additional Championship decals is determined by the Organiser. Exemption is given if decals are unavailable at the time.

C.4 CLASS DEFINITION & COMPETITION NUMBERS

- (i) There are no classes within HQ Holden Racing Appendix C 2025 MOTORSPORT AUSTRALIA WA HQ Holden Racing Championship.
- (ii) The competition number '1' shall be reserved for the sole use of the outright 1st placegetter of the previous year's state championship.
- (iii) Competitors may otherwise request a competition number from the Organiser, which shall be allocated for their *Driver's* use at each round of the Championship.

C.5 POINTSCORE

- (i) As per the 2025 Motorsport Australia WA State Circuit Racing Championship Sporting and Series Regulations Point Scores.
- (ii) If the annual "HQ Nationals" event falls within 10 days of a state championship *Round*, that state *Round* will not be awarded State Championship Points in the Championship.

C.6 CATEGORY ELIGIBILITY OFFICERS

(i) The Category Eligibility Officer will be appointed by the MOTORSPORT AUSTRALIA WA Motor Race Advisory Panel (WAMRAP). Interim or substitute Category Eligibility Officers may be added at any time by the Category Organisers which is to be ratified by WAMRAP, and the relevant Event Organisers and the Clerk of the Course are to be advised.

C.7 FURTHER TECHNICAL ELIGIBILTY

- (i) At any *Championship Round* any *Automobile* entered may, without prior notice, be subject to an eligibility/compliance inspection.
- (ii) A secondary seal may added to the engine, gearbox or differential.
- (iii) If an inspection cannot be carried out before a race, then an after-race inspection will be carried out, and the *Automobile* must remain in park fermé until this inspection is completed.
- (iv) The Competitor must be present at any inspection.
- (v) All prior sealing papers must be presented at the inspection and no seals are to be removed before examination by the Chief Scrutineer or Eligibility Officer.

C.8 GRID DETERMINATION

(i) Race grids and formats will be as per the 2025 Circuit Race Standing Regulations Clause 4.2 unless otherwise specified in the *Supplementary Regulations* for the *Event*.

C.9 RACE START PROCEDURES

(i) Races 1 and 2 for each *Event* shall be a standing start as outlined in Circuit Race Standing Regulations Clause 5.3 and Race 3 (and Race 4 if applicable) shall be a rolling start as outlined in Circuit Race Standing Regulations Clause 5.5, unless otherwise specified in the *Supplementary Regulations* for the *Event*.

C.10 CHAMPIONSHIP POINTS

(i) All races in Rounds 1 to 7 will count towards the 2025 State championship unless C.5(ii) is enforced.
