The Event will be held under the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) of Motorsport Australia, the Khanacross Standing Regulations, the Motorsport Australia Passenger Ride Activity Policy, Further Supplementary Regulations, which may be issued by the Organiser. The Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found on the Motorsport Australia website at

[www.motorsport.org.au](http://www.motorsport.org.au).

## PLACE AND DATE

The Event will be held at the Bendigo Livestock Exchange, Wallenjoe Road, Huntly and the Bagshot Motorsports Complex, Whirrakee Road, Bagshot North enter via Collins Road, during day light on Saturday and Sunday, 1<sup>st</sup> & 2<sup>nd</sup> November 2025.

## ENTRIES

Entries open on publication of these regulations and close at 5:00pm Monday 20<sup>th</sup> October.

An entry will only be deemed valid when payment is received with a completed entry.

All drivers must hold a minimum of a Motorsport Australia Speed/Speed Junior licence.

A maximum of 4 drivers per vehicle will apply.

## PRE-EVENT PAPERWORK

All competitors/drivers must present their current Motorsport Australia license and current club membership card to the paperwork checker at the secretary's desk prior to having their vehicles scrutineered. If issued, Motorsport Australia Vehicle Logbook must also be presented.

## VEHICLE ELIGIBILITY

Vehicles must conform to the Technical Appendix, Schedule A and Auto Test Appendix, Group 4K - Khanacross Technical Regulations of the Motorsport Australia Manual.

# SCRUTINY

Scrutiny will be at the Huntly Livestock Exchange.

Scrutiny will commence at 5:00pm Friday 31<sup>st</sup> October and all vehicles must be in the lineup by 7:30pm.

Scrutiny will finish at 8:00pm.

There will be limited scrutineering on Saturday 1<sup>st</sup> November at the Bendigo Livestock Exchange for those unable to attend on Friday, this will be appointment only from 7:30am

Vehicles will only be scrutineered **AFTER COMPLETING PRE-EVENT PAPERWORK.**

Motorsport Australia Scrutiny Declaration is to be completed and handed to scrutineer.

Only one vehicle representative is to enter the scrutiny shed with each vehicle.

Representative to follow scrutineer's directions during inspection of vehicle.

Vehicle Log Book (if issued), scrutiny slip & competition attire for all drivers must be presented with vehicle.

## DRIVERS BRIEFING

There will be 2 compulsory Driver briefings.

The first will commence at 8:45am Saturday 1<sup>st</sup> November at the Bendigo Livestock Exchange.

The Second will commence at 8:45am Sunday 2<sup>nd</sup> November at the Bagshot Motorsports Complex

The test sightings will follow after these briefings.

## INSURANCE

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at

## CLASSES

Class A: Production Cars: 0 to 1300cc

Class B: Production Cars: 1301 to 1600cc

Class C: Production Cars: Greater than 1600cc to 2000cc

Class D: Production Cars: Greater than 2001cc to 3000cc

Class E: Production Cars: Greater than 3000cc

Class F: 2WD Special (including FIA XC)

Class G: 4-Wheel Drive Production Cars

Class MP2: Highly Modified 2-Wheel Drive Production Cars, ie. Race/Rally cars or cars using Rally tyres or off-road, winter tread, bar-tread, mud-and-snow and hand-cut patterns.

Class MP4: Highly Modified 4-Wheel Drive Production Cars, ie. Race/Rally Cars or cars using Rally tyres or off-road, winter tread, bar-tread, mud-and-snow and hand-cut patterns

Category J: Juniors [refer note 1]

Category L: Ladies

Notes:

1. Juniors are defined as having attained the age of 12 years, and being under 18 years of age on the 1st November 2025

2. Note; a driver who enters a category is also entered in a class and may gain awards and points in both.

## **SPECIAL NOTES.**

- Any breaches of these Supplementary Regulations will be dealt with in the same manner as a breach of all other regulations pertaining to the Event.
- It is recommended that all vehicles display a front and rear marked tow point.
- Traveling speed away from the competition area will be at walking pace only, this includes approaching and leaving start and stop garages.
- It is the competitor's responsibility to line up in Numerical order for all tests.
- All vehicles must be fitted with two separate fastening systems on any front opening panel.
- Fire extinguishers to a standard listed in Technical Appendix, Schedule H of the Motorsport Australia Manual and must be securely fitted to the vehicle.
- All apparel must comply with Technical Appendix, Schedule D of the Motorsport Australia Manual.
- Driver's window **MUST** be up whilst competing unless window net or wrist restraints used.
- Penalties as per Khanacross Standing Regulations.

## **COURSE**

The Saturday section of the Event is on Hot-Mix Asphalt. A minimum of 6 tests and maximum of 12 tests will be conducted.

The Sunday section of the Event, the course surface is dirt/gravel. A minimum of 6 tests and a maximum of 12 tests will be conducted

The test courses will be determined by the clerk of the course.

Course markers may be witches' hats, tyres, bollards, etc.

## **RUNNING DETAIL**

The results will be calculated on the total of elapsed times of each Driver to complete each test conducted including any penalties incurred by the driver.

The winner shall be the driver/s having the lowest total time.

Timing will be a combination of electronic timing and handheld stopwatches.

## **TERMINATION**

The organisers reserve the right to stop the Event at any time if they consider it necessary, in the interests of safety or for any other reason.

In case of a Day of Total Fire Ban **NO ACTIVITY**, practice included, will be allowed.

# POSTPONEMENT

The Organiser reserves the right to postpone or stop the Event in accordance with the NCR, and if the event is cancelled or postponed for more than 24 hours, the entry fees shall be refunded in full.

# AWARDS

Trophies and prize will be awarded as follows:

Outright Positions:	1st to 6th
Vehicle Classes	1st, 2nd and 3rd
Driver Categories	1st, 2nd and 3rd

Class and Category Awards are subject to sufficient driver numbers as follows:

More than 6 driver's	1st, 2nd and 3rd places
4 to 6 drivers	1st and 2nd places
Less than 4 drivers	1st place only

# INTEGRITY

Smoking (which includes e-cigarettes and “vaping”) and any naked flame is prohibited

within 3 metres of any refuelling/defuelling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including

the Australian Anti-Doping Policy, Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at [www.motorsport.org.au](http://www.motorsport.org.au).

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia. Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

# NOISE

Vehicles must be ADEQUATELY muffled & not exceed a noise limit of 95dB.

# PROTESTS

Any Protests must be lodged in accordance with the NCR.

# FUEL

There will be no fuel available for purchase at either venue.

Fuel must be in accordance with Technical Appendix, Schedule G of the Motorsport Australia Manual.

# PASSENGERS IN COMPETITION VEHICLES

No passengers will be permitted in vehicles during competition runs

# CATERING

Refreshments and hot food will be available on both days at the venues.

## CODE OF CONDUCT

At no time may an Automobile be driven unnecessarily erratically or in a manner which could be deemed potentially dangerous to any other person or property. This will apply anywhere on the venue. Failure of a competitor to respect this rule may lead to disqualification from any further competition on the day.

## BENDIGO CAR CLUB MEMBERS ONLY

By entering the Motorsport Australia Khanacross Championship you will also gain entry in to Rounds 6 and 7 of the 2025/2026 Bendigo Car Club Championship.

## Risk Warning and Disclaimer

**Motorsport Activities are inherently dangerous recreational activities and there is significant risk of injury, disability or death.**

**If you do not wish to be exposed to such risks, then you should not participate in the Motorsport Activities.**

### Acknowledgement of Risks

I acknowledge that the risks associated with attending or participating in Motorsport Activities include but are **not limited** to the risk that I may suffer harm as a result of:

- motor vehicles (or parts of them) colliding with other motor vehicles or persons or property;
- other participants acting dangerously or with lack of skills;
- high levels of noise exposure;
- acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; and
- the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure my safety.

### Exclusion of Liability, Release and Indemnity

In exchange for being able to attend or participate in the Motorsport Activities, **I will and agree to:**

- to **release** Motorsport Australia and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
  - my **death**;
  - any **physical or mental injury** (including the aggravation, acceleration or recurrence of such an injury);
  - the contraction, aggravation or acceleration of a **disease** including but not only COVID-19;
  - the coming into existence, the aggravation, acceleration or recurrence of any other **condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs**:
    - that is or may be harmful or disadvantageous to me or the community; or
    - that may result in harm or disadvantage to me or the community;
  - any claim for any costs and expenses I may incur as a consequence of any of the above;
- arising from my participation in or attendance at the Motorsport Activities;
- to **indemnify and hold harmless and keep indemnified** Motorsport Australia and the Entities to the maximum extent permitted by law in respect of any Claim by any person; and
- to attend at or participate in the Motorsport Activities at my own risk.

### I understand that:

- nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of Motorsport Australia and the Entities as the supplier of the Motorsport Activities and Recreational Services;
- nothing in this document prevents Motorsport Australia and the Entities from relying on any laws (including statute and common law) that limit or preclude their liability;
- nothing in this document excludes any term or guarantee which under statute cannot be excluded, however the liability of Motorsport Australia and the Entities is limited to the minimum liability allowable by law;
- nothing in this document precludes me from making a claim under a Motorsport Australia insurance policy where I am expressly entitled to make a claim under that insurance policy; and
- Motorsport Australia has arranged for limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motorsport Activities. I acknowledge and accept that the insurance taken out by Motorsport Australia may not provide me with full indemnity for loss, damage or injury that I may suffer during my participation in the Motorsport Activities, and that I may have to pay the excess if a Claim is made under an insurance policy on my behalf. I agree that my own insurance arrangements are ultimately my responsibility and I will arrange any additional coverage at my expense after taking into account Motorsport Australia's insurance arrangements, this document and my own circumstances.

### Where Motorsport Activities are held in the following jurisdictions, I acknowledge that I have also read and accept the following warnings:

Under Australian Government Consumer Law (which is part of the **Competition and Consumer Act 2010 (Commonwealth)**), several guarantees are implied into contracts for the supply of certain goods and services. I agree that the application of all or any of the provisions of Subdivision B of Division 1 of Part 3-2 of Australian Consumer Law (i.e. guarantees relating to the supply of services), the exercise of rights conferred by those provisions, and any liability of Motorsport Australia and the Entities for a failure to comply with any such guarantees, are excluded. Under **The Australian Consumer Law (Victoria)**, several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to me:

- are rendered with due care and skill;
- are reasonably fit for any purpose which I either expressly or by implication, make known to the supplier; and
- might reasonably be expected to achieve any result I have made known to the supplier.

Under section 22 of the **Australian Consumer Law and Fair Trading Act 2012 (Vic)**, the supplier is entitled to ask me to agree that these conditions do not apply to me. I understand that if I sign this form, I am agreeing that any rights to sue the supplier under the **Australian Consumer Law and Fair Trading Act 2012** if I am killed or injured because the services were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form.

**Note:** I note that the change to my rights, as set out in this form, does not apply if my death or injury is due to gross negligence on the supplier's part.

"Gross negligence" in relation to an act or omission, means doing the act or omitting to do an act with reckless disregard, with or without consciousness, for the consequences of the act or omission. ### Warning Applicable in Relation to Motorsport Activities Held in South Australia

Under sections 60 and 61 of **The Australian Consumer Law (SA)**, if a person in trade or commerce supplies me with services (including recreational services), there is a statutory guarantee that those services:

- will be rendered with due care and skill; and
- any product resulting from those services, will be reasonably fit for the purpose for which the services are being acquired (as long as that purpose is made known to the supplier); and
- any product resulting from those services, will be of such a nature, and quality, state or condition, that they might reasonably be expected to achieve the result that the consumer wishes to achieve, (as long as that wish is made known to the supplier or a person with whom negotiations have been conducted in relation to the acquisition of the services).

### Excluding, Restricting or Modifying My Rights:

Under section 42 of the **Fair Trading Act 1987 (SA)**, the supplier of recreational services is entitled to ask me to agree to exclude, restrict or modify their liability for any personal injury suffered by me or another person for whom, or on whose behalf, I am acquiring the services (a third party consumer). If I sign this form, I am agreeing to exclude, restrict or modify the supplier's liability with the result that compensation may not be payable if I or the third party consumer suffer personal injury.

### Important:

I do not have to agree to exclude, restrict or modify my rights by signing this form. The supplier may refuse to provide me with the services if I do not agree to exclude, restrict or modify my rights by signing this form. Even if I sign this form, I may still have further legal rights against the supplier. A child under the age of 18 cannot legally agree to exclude, restrict or modify their rights. ### Agreement to exclude, restrict or modify my rights:

### Definitions:

- "Motorsport Activities" means any motorsport activities or Recreational Services which are permitted or approved which Motorsport Australia regulates or administers or otherwise are under the responsibility / control of Motorsport Australia;
- "Motorsport Australia" means the Confederation of Australian Motor Sport Ltd. trading as Motorsport Australia;
- "Reckless Conduct" means conduct where the supplier of the recreational services is aware, or should reasonably have been aware, of a significant risk that the conduct could result in personal injury to another person and engages in the conduct despite the risk and without adequate justification;
- "Recreational Services" means (unless otherwise defined in this document) services that consist of participation in:
  - a sporting activity; or
  - a similar leisure time pursuit or any other activity that:
    - involves a significant degree of physical exertion or physical risk; and
    - is undertaken for the purposes of recreation, enjoyment or leisure.

### Fit and Proper Person

I acknowledge and agree that it is a fundamental condition of issue of this licence and its continuing validity that I:

1. have advised Motorsport Australia in writing of any act, omission, fact or circumstance which may affect my ability to be and remain a fit and proper person to hold this licence and exercise the duties and privileges that relate to it;
2. have advised Motorsport Australia in writing if I have been found guilty of or charged with any:
  - a. serious indictable criminal offence; or
  - b. sexual offence, (unless this is a 'spent' or 'annulled'<sup>1</sup> conviction); and
3. undertake to advise Motorsport Australia immediately in writing upon any court of competent jurisdiction making any such finding, or upon being charged with any such offence.

I acknowledge and agree that Motorsport Australia may, in its absolute discretion (subject to this clause) refuse to issue, suspend or withdraw this licence at any time should Motorsport Australia reasonably form the view that I may not be, or am not, a fit and proper person to be granted or hold this licence and/or exercise any of the duties and/or privileges that arise from, or relate, to it, however I understand that before a licence is refused, suspended or withdrawn by Motorsport Australia I will be afforded the opportunity to address the Motorsport Australia Board in writing on the proposed refusal, suspension or withdrawal.
