# 2025 SUPPLEMENTARY REGULATIONS MOTORSPORT AUSTRALIA MOTORKHANA CHAMPIONSHIP



1. The event will be conducted under the FIA International sporting code including Appendices and the National Competition Rules (NCR) of Motorsport Australia, The Motorkhana Standing Regulations, these Supplementary Regulations and any further Supplementary Regulations or bulletins which may be issued. This event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1<sup>st</sup>, Integrity & Legal and Risk Management Policies. Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. #### 17. ENTRIES

Entries open on publication of these regulations. This is a "pre-entry" only event and entries and payments cannot be taken on the day. All pre-entries must be received by 8:00pm SA time on Friday, 19<sup>th</sup> September 2025.

All Competitors and Drivers must be a member of a Motorsport Australia affiliated club and be in possession of a current Motorsport Australia Competition License Speed / Speed Junior or Higher. Proof of club membership must be produced during documentation for a visual check.

Entries will only be accepted via the Motorsport Australia Online Event Entry portal, which must be completed in all details. Entries from Competitors / Drivers under 18 years of age must be counter signed / consented to by a Parent / Guardian.

#### 18. FEES & PAYMENT

ADULTS: \$110

**JUNIORS:** \$55 (Less than 18 years of age on 18<sup>th</sup> October 2025

#### 19. PAYMENT:

Competitors are requested to enter early to assist the Organisers with tasks such as printing of the program and publicity material.

Competitors are also asked to provide information, where indicated on the 'Publicity Form', to be used in the Event publicity and on the day of the event. By filling this form out and signing the document you authorise that this information can be used with the media and publicity for the Event.

#### 20. MAXIMUM NUMBER OF COMPETITORS: 90

Preference will be given in order of receipt of entry. The organiser reserves the right to refuse any entry in accordance with the NCR.

#### 21. MAXIMUM ENTRIES PER VEHICLE: 4

Not more than 4 Drivers may be entered to drive the same Automobile. At the Clerk of the Course's discretion this number may be extended for a family unit. Please email Secretary of the Event, should you wish to apply for an exemption to this limit.

#### 22. COMPETITION NUMBERS

A ballot for competition numbers will be held at 8pm on Sunday, 21<sup>st</sup> September 2025, and then they will be sent out directly to all Competitors as well as made available for viewing on the Australian Motorkhana Facebook page.

#### 23. VEHICLES

All vehicles must comply with Schedule A (refer Motorsport Australia Manual; Technical Appendix) and with the Group 4H Technical Regulations, (refer to the Motorsport Australia Manual, Autotest Appendix)

Specials are defined in Article 3 of the Group 4H Technical Regulations. Please note the Special criteria for Production Based Vehicles in Article 3.1.2 of Group 4H Technical Regulations.

The Clerk of the Course shall determine the appropriate class wherein each vehicle shall be classified if there is any dispute as to entry class as per Motorkhana Standing Regulations.

#### 24. VEHICLE CLASSES

As per Motorkhana Standing Regulations, Vehicle Classes (based on manufacturers' specifications for production cars) shall be:

#### 25. ADDITIONAL DRIVER CATEGORIES

Additional driver catorgories are as follows:

L	Ladies - Fastest Outright
LP	Ladies Production - Fastest in a Production Car
J	Junior - Fastest outright
JP	Junior Production - Fastest in a Production Car

To quailfy for categories J and / or JP, the Driver must be less than 18 years but more than 12 years of age on the day of the AMC as specified in Regulation 15 of the Motorkhana Standing Regulations. The driver may be required to supply proof of age.

#### 26. AWARDS

Awards as per the Motorkhana Standing Regulations will be presented at the Post Event Function held on the Sunday evening of the AMC. Other awards may be presented at the discretion of the Organiser. Trophies will be awarded as follows:

#### 27. TEAM AWARDS

Driver teams may compete for a team award. Each team is to be nominated to the Secretary of the Event by 12:00pm Saturday 18<sup>th</sup> October 2025 and shall consist of three (3) Drivers competing in at least two vehicle classes. A driver may be nominated for only one team.

Final aggregate time for each team member will be adjusted by a handicap factor (as listed below).

The team with the overall lowest aggregate handicap time will be determined the winner. All penalties are calculated at a factor of 1.00, not at the handicap factor.

The Handicap factor to be applied to each team member is based on vehicle classes as follows:

#### 28. SCRUTINEERING

All competitors must have completed the MSA Statement of Vehicle Compliance Form.

Scrutineering will be held at the competition venue between 10:00am-1:00pm on Saturday 18<sup>th</sup> October 2025. No vehicle may be used to practice or compete without having first passed scrutineering and completed Documentation. Please enter the scrutineering area in an orderly manner. Only competing vehicles are allowed in the scrutineering area.

Before being allowed to compete, Competitors must present a copy of a current and valid Motorsport Australia Speed / Junior Competition License or superior, and Club Membership Card of a Motorsport Australia - Affiliated Car Club and vehicle log book (if issued), unless prior approval has been obtained from the Organiser for alternative scrutineering arrangements, which will only be granted in exceptional circumstances. Motorkhana - Approved helmets in accordance with Technical Appendix Schedule D of the Motorsport Australia Manual are to be worn in ALL Class F, Class G or Class H Vehicles. Apparel shall be in accordance with Technical Appendix Schedule D of the Motorsport Australia Manual. All vehicles must comply with Technical Appendix Schedule G of the Motorsport Australia Manual.

Particular attention will be given to:

- · Battery security
- Safe conditions of suspension and brakes
- Roll over protection structures (if fitted)
- · Safety harness / seat belts
- Tyres
- All vehicles must be effectively muffled, as required by Group 4H Technical Regulations
- Attention will be paid to the cleanliness and tidiness of vehicles

Any camera or video recording device mounted in or on a competition vehicle must be installed as per manufacturer requirements.

Vehicles that have a mechanical failure at any time after the vehicle has been initially scrutineered may be required to present the vehicle for Re-Scrutineering.

#### 29. APPAREL

Whilst practicing or competing, all Drivers must wear a seat belt complying with Technical Appendix - Schedule I of the Motorsport Australia Manual. All apparel must be in accordance with Technical Appendix - Schedule D of the Motorsport Australia Manual.

Competitors are reminded that during practice and competition, Drivers of "Specials" (as defined by Group 4H Technical Regulations) are required to wear a helmet complying with Level B standards listed in Technical Appendix Schedule D of the Motorsport Australia Manual.

Drivers of "Specials" and vehicles not fitted with a windscreen must wear proper eye protection (not sunglasses) complying with Technical Appendix Schedule D during practice and competition.

#### 30. REFUELLING OF VEHICLES

All refuelling of competition vehicles will be completed in the designated area with at least two people present (one to refuel and one to operate fire extinguishers). All persons refuelling must be wearing appropriate flame resistant clothing and substantial footwear.

Any vehicles being refueled must have the engine turned off. The vehicle must not have any occupants during the refuelling procedure.

Competitors are reminded that fuel must be in accordance with the Technical Appendix Schedule G of the Motorsport Australia Manual.

Fuel is not available at the venue.

#### 31. PRACTICE

Practice will be permitted on Saturday, 18<sup>th</sup> October 2025 for those competitors who have completed Documentation and vehicle has passed scrutineering. No practice is scheduled for the Sunday of the AMC.

#### **32. TESTS**

A minimum of four (4) and a maximum of twelve (12) tests will be conducted, chosen by the Organiser from the following list tests from Part A of the Motorsport Australia Motorkhana Tests Booklet.

Mothballs Open Slalom

Corridor Gables Six Gate Atom

Plumb Crazy Noughts & Crosses

Paddy Dollar Hopkirk Hopscotch

Only one attempt will be permitted at each test, with the exception of a rerun having been granted by the Clerk of the Course.

Test diagrams printed in the 2025 Australian Motorkhana Championship Program are taken from the Motorsport Australia Motorkhana Tests Booklet. A copy of the program will be available to all competitors.

The Clerk of the Course reserves the right to add other tests from the current Motorsport Australia Motorkhana Tests Booklet.

#### 33. EVENT LAYOUT

The layout of each test as laid down in the schedule of the Motorsport Australia Motorkhana Tests Booklet shall be strictly adhered to, subject to a tolerance of +/-200mm in dimension, as specified in the Motorkhana Standing Regulations.

The Organiser reserves the right to modify the tests to fit the restricted area used, competitors will be informed of any modification in and Further Supplementary Regulations.

#### 34. TIMING

Electronic timing will be used on each test, backed up by hand - held stop watches. Timing will be to .01 of a second and will be recorded in writing.

Timing will start when the leading point of the vehicle crosses the designated start line and will stop when the leading point of the vehicle crosses the finish line. The designated start and finish line will be a line across the start and finish garage that is not more than one metre and not less than 500mm behind the front of the garages.

Large Display clocks only show elapsed time. Official times may be different depending on penalties applied.

"Provisional results may be available to be viewed on the day - location to be advised at drivers briefing.

#### 35. STARTING ORDER

The starting order on each test will be determined by a rotational system based on classes. Details will be notified in Further Supplementary Regulations and repeated at the Drivers' Briefing.

#### 36. SHOOTOUT

The Clerk of the Course reserves the right to run a shoot-out at the end of the competitive day if time permits. The Shoot-out shall not have any bearing on the results of the AMC.

The method of determining Driver eligible for the shoot-out and the handicap or Driver Performance Index (DPI) used to determine the winner of the shoot-out shall be announced at the Drivers Briefing.

#### 37. PROTESTS

Protests must be lodged on accordance with the NCR.

#### 38. FOOD AND AMENITIES

Food and drinks will be available for purchase on both Saturday, 18<sup>th</sup> October and Sunday 19<sup>th</sup> October 2025. We encourage you to support the venue by purchasing food and drinks.

#### 39. GENERAL INFORMATION

The organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR,

Smoking on the premises is not permitted in any pit and event areas, seated, thoroughfare and concourse areas and buildings. Smoking (Which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling / defuelling operation.

#### 40. Integrity, Alcohol, Drugs and Other Substances

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at Motorsport.org.au. Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia. Consumption of alcohol in any Reserved Area is prohibited until all Competitions is concluded each day.

#### 41. PRIZE PRESENTATION FUNCTION

The South Eastern Automobile Club (SEAC) will be hosting a Prize Presentation Function on Sunday, 19<sup>th</sup> October 2025 at 'The Little Rippa Brewing Company', 107 Ruwoldt Road, Yahl SA 5291.
