STRATEGIC DISCUSSIONS:

Strategic Plan Update

The Board noted the Information Paper providing a summary of the proposed process to deliver the Strategic Plan and the underlying cascading strategies.

Implementation of the Targa Review Panel Findings

The Board resolved to:

- not permit the sanctioning of Targa style Tarmac Rallies before 1 July 2023 to allow Management, event Promoters and Competitors sufficient time to implement all of the recommendations of the Targa Review Panel;
- adapt the recommendations of the Review Panel as they relate to Tours with immediate effect to allow the sanction of Tour events; and
- release the Targa Review Panel Report in full, with the precise timing of the release and a communications plan to be undertaken by management.
