#### **Matters from Race 2**

##### Deputy Race Director Incident Determinations

The DRD together with the DSA investigated the following Incident contact between Car 38 Cameron Crick and Car 55 Rylan Gray at turn 1 Lap 6 during the Race by reviewing the available broadcast vision and determined they did not warrant referral to the Stewards as no breach of the Rules was established:

##### Stewards' Decisions – Penalties imposed.

After receiving a report from the DRD and reviewing the available broadcast vision and consulting the DSA, the Stewards imposed a 5 second Time Penalty on Car 11 Zane Morse 8 for a False Start – D8.1.10.2 car incorrectly position when the lights were extinguished.

After receiving a report from the DRD and reviewing the available broadcast vision and consulting the DSA, the Stewards imposed a 5 second Time Penalty on Car 20 Reuben Goodall for a Driving Infringement – Schedule B2, Article 3.3.2 - Careless rejoining the track at Turn 22.

After receiving a report from the DRD and reviewing the available broadcast vision and consulting the DSA, the Stewards imposed a 30 second Time Penalty on Car 25 Zach Bates for a Driving Infringement – Schedule B2, Article 2.1.1 - Careless Driving – contact with Car 88 at Turn 4 on Lap 6.

After receiving a report from the DRD and reviewing the available broadcast vision and consulting the DSA, the Stewards imposed a 15 second Time Penalty on Car 11 Zane Morse a Driving Infringement – Schedule B2, Article 2.1.1 - Careless Driving – contact with Car 9 at Turn 22 on Lap 10.
